Superintendent Jesse Najera reported to the Governing Board that recently he attended the NAFIS 2023 Fall Conference, which went great. For CAFIS, they were able to host a luncheon during the NAFIS Conference, and they honored Senator Dianne Feinstein with a "Champion for Impact Aid" award. 6.13 Consider Approval of the Second Reading, AR/EX 1312.4 Williams Uniform Complaint Procedures

The Regulation was updated to reflect NEW STATE REGULATIONS (Register 2020, No. 21) which amends the definition of "beginning of the year or semester" and NEW LAW (AB 367, 2021) which requires any school serving any of grades 6-12 to, at all times, stock and make available and accessible free of cost an adequate supply of menstrual products in specified restrooms beginning with the 2022-23 school year.

The Regulation was also updated to clarify that the principal or Superintendent's designee is required to send a written resolution of the complaint to the mailing address of the complainant when the complainant has indicated on the complaint form a desire to receive a response to the complaint. The Exhibit was updated to include that, for a school that serves any of grades 6-12, a complaint may be filed for failure to, at all times, stock and make available and accessible free of cost an adequate supply of menstrual products in specified restrooms, as required by NEW LAW.

Also, updates were made to the Exhibit regarding the quarterly summary report.

information about health care options as the law requiring such information has self-repealed, and clarify that a student's residence is a location within the district that may be verified as part of school admission requirements.

The Regulation was updated for consistency with NEW LAW (AB 130, 2021) which revises the timespans for transitional kindergarten (TK) admittance requirements to be phased in from the 2022-23 school year to the 2025-26 school year, as reflected in BP 6170.1 - Transitional Kindergarten.

Californians for Drug-Free Youth, Inc. sponsored the first statewide Red Ribbon Campaign in 1986, and the National Federation of Parents; Inc. sponsored the first national campaign in 1988. People were invited to wear and display red ribbons to demonstrate their commitment to a healthy, drug-free lifestyle - meaning no use of illegal drugs, and no illegal use of legal drugs.

Red Ribbon Week has grown into a major national observance offering communities the opportunity to demonstrate their commitment to healthy, drug-free lifestyles. In addition to the ongoing drug prevention programs, our district acknowledges Red Ribbon Week with various activities.

Red Ribbon Week is designated for October 23-31 2023, and the theme for this year is "Be Kind to Your Mind. Live Drug-Free."

WHEREAS, approximately 480,000 yellow school buses carry 25 million children to and from school every weekday; and

WHEREAS, America's 480,000 school buses comprise the largest mass transportation fleet in the country, 2.5 times the size of all other forms of mass transportation - transit, intercity buses, commercial airlines, and rail - combined; and

WHEREAS, during the school year, school buses make more than 50 million passenger trips daily carrying the Nation's future--our children; and

WHEREAS, school bus transportation is eight times safer than traveling in a passenger vehicle and is the safest form of ground transportation available; and

WHEREAS, school buses meet higher construction, equipment, and inspection standards than any other vehicle, and school bus drivers meet higher qualification, training, and testing standards than any other drivers; and

WHEREAS, according to the National Academy of Sciences, an average of 820 students are killed annually during school transportation hours, but less than 2 percent of them are school bus passengers; and

WHEREAS, despite the industry's best efforts, accidents still happen; and

WHEREAS, an average of seven school-age passengers is killed in school bus crashes each year, and an average of 19 children are killed each year getting on and off the bus; and

WHEREAS, most of those killed are children aged five to seven, and most often those children are killed in the area immediately surrounding the bus - either by a passing vehicle or by the bus itself; and

WHEREAS, School Bus Safety Week, which is celebrated in more than 40 States and sponsored by the National Highway Traffic Safety Administration (NHTSA), was created to remind all students of the best ways to get on and off the bus in an effort to enhance the safety of the Nation's children; and

WHEREAS, School Bus Safety Week, which dates back to 1966, also recognizes the hard work and dedication of school transportation personnel, especially the many school bus drivers who ensure a safe journey each and every day; and

WHEREAS, School Bus Safety Week, celebrated the third week in October, promotes awareness through activities built around themes that raise awareness of school bus safety issues.

NOW, THEREFORE, BE IT RESOLVED that the Silver Valley Unified School District supports the goals and ideals of School Bus Safety Week, and recognizes October 16-20, 2023 as **School Bus Safety Week**.
