## 7.13 Consider the Approval of an Overnight Field Trip, SVHS Students to Knott's Scary Farm October, 20-21, 2023

Select Yearbook and ASB students will be going to Knott's Scary Farm as a team-building experience, and the Yearbook students will also be practicing/night action photography. The student board members from the Yearbook club and ASB were invited, as well as randomly selected students from each club, for a total of fourteen students who will be attending this event. (Seven students from the Yearbook club and seven students from ASB.) The students were selected through a random name generator to allow for full fairness and openness. The students will be transported to/from Knott's Berry Farm in district vehicles, with teachers Wade Backlund and Stephanie Luna driving and chaperoning. Parking and tickets will be paid for by the clubs. They will be stopping for food along the way to the park and students will be able to purchase food at the theme park. This is an overnight trip leaving the school at 4:00 p.m. on Friday, October 20, 2023, and returning at 4:00 a.m. on Saturday, October 21, 2023.

## D) Board Policies, Second Readings

## 7.14 Consider the Approval of the Second Reading and Adopt BP/AR 3516 Emergencies and Disaster Preparedness Plan

The policy expands the paragraph on the involvement of staff and community groups in plan development, consistent with the U.S. Department of Education recommendation. The policy also adds training on staff responsibilities in an emergency or disaster, clarifies staff's legal obligation to serve as disaster service workers, and clarifies that board members are not considered disaster service workers.

The regulation expands prevention strategies to include measures to increase the security of school facilities, expands crisis communications methods to include social media and electronic

communications, and adds assembly of key information into a "crisis response box" that can be easily accessed in an emergency.

**Recommendation**: It is recommended that the Governing Board of Trustees approve the second reading and adopt BP/AR 3516 Emergencies and Disaster Preparedness Plan.

## 7.15 Consider the Approval of the Second Reading and Adopt BP/AR 5131.7 Weapons and Dangerous Instruments

Policy updated to (1) expand the concept of district provided transportation, (2) reflect NEW LAW (SB 906, 2022) which requires certificated and classified employees of the district, and other school officials such as Governing Board members, whose duties bring the employee or other school official in contact on a regular basis with students in any of grades 6-12, as part of a middle school or high school, who are alerted to or observe any threat or perceived threat of a homicidal act, to immediately report the threat or perceived threat to law enforcement, (3) move language regarding student suspension and expulsion in order to keep related content together, and (4) add language regarding staff training to align with staff responsibilities to report potential homicidal acts.

The regulation was updated to expand the list of prohibited weapons and dangerous instruments to include additional items that are listed in the law. The regulation was also updated to add headings for the Options regarding tear gas or tear gas weapons and to emphasize that for districts that allow students to bring tear gas of tear gas weapons to school, the student needs to either be accompanied by or have written consent, of a parent/guardian.

The regulation has been updated to include the use of therapy dogs at school sites within the district. At the discretion of the Superintendent and/or designee, a qualified owner and therapy dog may be used at the school sites to help support students' and adults' social and emotional needs.

## 7.17 Consider the Approval of the Second Reading and Adopt BP 6170.1 Transitional Kindergarten

Policy updated to reflect NEW LAW (AB 130, 2021) which (1) gradually revises the timespans for mandatory transitional kindergarten (TK) admittance such that, by the 2025-26 school year, children who turn four by September 1 will be eligible for TK, (2) establishes the California Prekindergarten Planning and Implementation Grant Program as an early learning initiative with the goal of expanding access to classroom-based prekindergarten programs at districts, including but not limited to TK programs, and which requires districts to develop a plan for how all children in the attendance area of the district will have access to full-day learning programs the year before kindergarten, (3) establishes the California Preschool, Transitional Kindergarten, and Full-Day Kindergarten Facilities Grant Program to provide one-time grants to school districts to construct new school facilities or retrofit existing school facilities including for the purpose of providing TK classrooms, (4) prohibits TK eligibility from impacting family eligibility for a preschool or childcare program, and (5) requires districts to maintain an average TK class enrollment of not more than 24 students for each school site and which, commencing with the 2022-23 school year, requires districts to maintain an average of at least one adult for every 12 students for TK classrooms and, contingent upon an appropriation of funding, maintain an average of at least one adult for every 10 students commencing with the 2023-24 school year. Policy also updated to reflect requirements for programs that commingle preschool-age and TK students.

## 10.2 Resolution No. 23-24-02: GANN Limit

In November of 1979, California voters approved Proposition 4, an initiative that added Article XIII B to the California Constitution. This constitutional amendment, known as the Gann Initiative, placed limits on the growth of expenditures for publicly funded programs. Division 9 of Title 1, beginning with Section 7900 of the Government Code, was then added to law to specify the process for calculating state and local government appropriation limits and appropriations subject to limitation under Article XII B of the Constitution. These constitutional and statutory sections explain and define the appropriations limit and appropriations subject to limitation as they apply to state and local government, and require that each entity of government formally "adopt" its appropriations limit for a given fiscal year. By September 30th of each year, Education Code sections 1629 and 42132 specify that each county office and district Governing Board shall adopt a resolution identifying their estimated appropriations limits for the current year and their actual appropriations limit for the preceding year. The documentation supporting the adoption resolution shall be made available to the public.

**Recommendation**: It is recommended that the Governing Board of Trustees adopt Resolution No. 23-24-02 GANN Limit as presented.

The Regulation was updated to reflect NEW STATE REGULATIONS (Register 2020, No. 21) which amends the definition of "beginning of the year or semester" and NEW LAW (AB 367, 2021) which requires any school serving any of grades 6-12 to, at all times, stock and make available and accessible free of cost an adequate supply of menstrual products in specified restrooms beginning with the 2022-23 school year. The Regulation was also updated to clarify that the principal or Superintendent's designee is required to send a written resolution of the complaint to the mailing address of the complainant when the complainant has indicated on the complaint form a desire to receive a response to the complaint.

The Exhibit was updated to include that, for a school that serves any of grades 6-12, a complaint may be filed for failure to, at all times, stock and make available and accessible free of cost an adequate supply of menstrual products in specified restrooms, as required by NEW LAW. Also, updates were made to the Exhibit regarding the quarterly summary report.

**Recommendation**: It is recommended that the Governing Board of Trustees approve the first reading of Administrative Regulation and Exhibits 1312.4 Williams Uniform Complaint Procedures.

The Regulation was updated for consistency with NEW LAW (AB 130, 2021) which revises the timespans for transitional kindergarten (TK) admittance requirements to be phased in from the 2022-23 school year to the 2025-26 school year, as reflected in BP 6170.1 - Transitional Kindergarten.

**Recommendation**: It is recommended that the Governing Board of Trustees approve the first reading of Board Policy and Administrative Regulation 5111 Admission.

WHEREAS, the Governing Board is the highest level of decision-making authority, and has the authority to commit, assign, or evaluate existing fund balance classifications and identify the intended uses of committed or assigned funds; and

WHEREAS, the committed fund balance classification reflects amounts subject to internal constraints self-imposed by the Governing Board; and

WHEREAS, once the committed fund balance constraints are imposed, it requires the constraint to be removed by the Governing Board prior to redirecting the funds for other purposes; and

WHEREAS, it is acknowledged that facility requirements and investments are major expenditures that are necessary to ensure that all facilities are safe, adequate and properly maintained, and that it is necessary to invest in capital projects to meet the changes in the delivery of educational services.

WHEREAS, it is further acknowledged that other non-instructional expenditures are necessary to ensure the on-going operations of the District.

**NOW, THEREFORE, BE IT RESOLVED** that the Silver Valley Unified School District Board of Trustees, in accordance with the provisions of GASB 54 hereby commits \$3,750,000 state funding for Impact Aid Stabilization Reserve in Fund 01, as indicated by the Committed Fund classification. Funds cannot be used for any purpose other than referenced above, unless the Governing Board adopts another resolution to remove or change the constraint.
