What are Unaudited Actuals?

- Districts must prepare yearend financial statements as of June 30 using the state format known as SACS (Standardized Account Code Structure) for all district funds
- On or before October 15, 2021, the COE shall verify the accuracy of the statements and submit a copy to the State Superintendent of Public Instruction
- The report is subject to audit by external auditors
- The audit report is due to the state and COE no later than December 15, 2021
