We hereby propose to furnish material and labor necessary for the completion of:

- Demo 90 linear feet of block wall. Saw cut block where awning post go into block and patch columns.
- Demo existing 30' x 30' concrete slab in block area
- Set, Place, and pour 30' x 32' slab in area where block and concrete was demoed
- Set, place, and pour 31' x 4' of sidewalk with curb against portable to keep water from rotting out siding.
- Replace 40' of rotted siding on existing portable. New siding will be painted to match existing.
- Provide and install bike rack.
- Install three 4" bollards in front of bike rack
- All concrete will be poured 5" thick with a 3,000 psi 3/4" rock mix and wire mesh.
- Job is bid for prevailing wage.

All material is guaranteed to be as specified. All work to be completed in a substantial workmanlike manner according to specifications submitted, per standard practices. Any alteration or deviation from above specifications involving extra costs will be executed only upon written orders, and will become an extra charge over and above the estimate. All agreements contingent upon strikes, accidents or delays beyond our control. Owner to carry fire, tornado and other necessary insurance. Our workers are fully covered by Workmen's Compensation Insurance. If either party commences legal action to enforce its rights pursuant to this agreement, the prevailing party in said legal action shall be entitled to recover its reasonable attorney's fees and costs of litigation relating to said legal action, as determined by a court of competent jurisdiction. Contractors are required by law to be licensed and regulated by the Contractor's State License Board which has jurisdiction to investigate complaints against contractors if a complaint regarding a patent act or omission is filed within four years of the date of the alleged violation. A complaint regarding a latent act or omission pertaining to structural defects must be filed within 10 years of the date of the alleged violation.
