We hereby propose to furnish material and labor necessary for the completion of:

- Demo one of two trees in planter.
- re-route irrigation for remaining tree.
- Install ¾" tan rock around tree and replace remainder of planter with Concrete.
- Demo 400 sqft of failed concrete Sidewalk
- Replace/repair fence post footings once concrete is demoed.
- over-x one foot down in area where concrete is getting replaced to remove surface roots and subgrade back with recycled base.
- Set, place, and pour 900 sqft of Concrete flatwork/sidewalk along the iron fence in front of the school and area where tree was removed.

We propose hereby to furnish material and labor – complete in accordance with above specifications for the sum of:
Twenty Two Thousand Two Hundred & Forty dollars (\$ 22,240)

Payment as follows: upon completion

All material is guaranteed to be as specified. All work to be completed in a substantial workmanlike manner according to specifications submitted, per standard practices. Any alteration or deviation from above specifications involving extra costs will be executed only upon written orders, and will become an extra charge over and above the estimate. All agreements contingent upon strikes, accidents or delays beyond our control. Owner to carry fire, tornado and other necessary insurance. Our workers are fully covered by Workmen's Compensation Insurance. If either party commences legal action to enforce its rights pursuant to this agreement, the prevailing party in said legal action shall be entitled to recover its reasonable attorney's fees and costs of litigation relating to said legal action, as determined by a court of competent jurisdiction. Contractors are required by law to be licensed and regulated by the Contractor's State License Board which has jurisdiction to investigate complaints against contractors if a complaint regarding a patent act or omission is filed within four years of the date of the alleged violation. A complaint regarding a latent act or omission pertaining to structural defects must be filed within 10 years of the date of the alleged violation. Any questions concerning a contractor may be referred to the Registrar, Contractor's State License Board, P.O. Box 26000, Sacramento, California 95826.
