

AGREEMENT FOR CONSULTANT SERVICES
Silver Valley Unified School District

THIS AGREEMENT is made and entered into this ____ day of _____, 2021, by and between SILVER VALLEY UNIFIED SCHOOL DISTRICT ("DISTRICT") and INTEGRATED THERAPIES, A FAMILY COUNSELING CORPORATION ("CONSULTANT").

Service to be provided by Consultant:

- a. CONSULTANT will render the following services as described: Counseling provided by a licensed Marriage and Family Therapist, to include counseling for individuals, groups, in-crisis situations, families, and staff, if needed. Topics for counseling will be determined by the presenting problem or by referring personnel.
- b. CONSULTANT will manage allotted time within the confines of this agreement. Duration of this agreement is from August, 2021, through June, 2022. Services to be provided as scheduled and billed at \$115.00 per hour. Total billings will not exceed \$30,000.00 without a written amendment to this agreement.
- c. CONSULTANT will complete, in a timely manner, records and forms as required for medical billing. An attendance record will be kept for billing and reimbursement purposes. All notes from counseling sessions will be used as information only and will not be considered medical records. Any notes will remain in the possession of CONSULTANT and will be destroyed at the conclusion of this Agreement.
- d. CONSULTANT will perform said services in her own way and as an independent contractor in the pursuit of her independent calling and not as an employee of the DISTRICT. Client caseload will be determined by need and type of intervention and will be best determined after assessing the makeup of the students and their related issues.

Consultant's Fee and Payment Thereof:

DISTRICT will pay CONSULTANT for services rendered under this Agreement the amount or amounts set forth in the payment terms below:

CONSULTANT Fees: Fees will be charged at \$115.00 per hour as services are provided. Statements of service to be submitted ONCE a month or as requested. Total fees billed shall not exceed \$30,000.00.

Payment of Fees: DISTRICT will render payment for services as billed within thirty (30) days from the statement date.

Duration of Agreement:

This Agreement shall be for the period of August 1, 2021 through June 30, 2022 and may be extended with the agreement of both parties.

Hold Harmless:

CONSULTANT hereby agrees to save and hold harmless DISTRICT and its departments, agencies, officers or employees from all sums which DISTRICT or any of its departments, agencies, officers or employees may be obligated to pay by reason of any liability imposed upon them for damages arising out of the performance of the services rendered by CONSULTANT or of any employed by her or of any others for whose acts CONSULTANT is legally liable.

Successors and Assigns:


This Agreement shall not be assigned except with the written consent of the parties hereto.

Special Provisions:

- a. CONSULTANT shall comply with all federal, state and local laws and ordinances applicable to her work. CONSULTANT shall self-insure her services and provide evidence of that insurance upon request.
- b. This Agreement may be amended only by the mutual written consent of the parties hereto.
