Scope: pull out existing fire alarm wiring, fiber, com and power wires to re-route away from gymnasium footing. Pulled out 2 existing fiber lines and pulled back in through new conduits and j-boxes installed by others. Each run totaling 950'. Pulled in 750' run for future gymnasium. Re-routed 180' of 2" PVC away from gymnasium footing for power to office. Pulled in 420' of new 1/0 copper wire and made up. Hooked up temp generator while office power was down. Pulled out existing communication and fire alarm wiring and rerouted through new conduits and j-box's installed by others.

Labor - \$25,975

Materials - 1/0 wire, mule tape, string line, tape, connectors for temp power - \$6,865. Fiber make-ups - \$2,500. Generator rental, delivery and pick up - \$2,900. Generator fuel - \$535. Service trucks, tools and equipment - \$2,500. Total before bond - \$41,275. Bond - \$1,300. Total = \$42,575
