

**2024-25 CTE Incentive Grant (Round 10) Participating District  
Memorandum of Understanding**

**Whereas**, Apple Valley Unified School District, Barstow Unified School District, Hesperia Unified School District, Lucerne Valley Unified School District, Silver Valley Unified School District, Snowline Joint Unified School District, Trona Joint Unified School District, and Victor Valley Union High School District have agreed to form a consortium for the purpose of the CTE Incentive Grant; and

**Whereas**, the Apple Valley Unified School District has agreed to be the Lead Agency for the CTE Incentive Grant; and

**Whereas**, the term of this MOU shall be from July 1, 2024 through June 30, 2027 unless modified or terminated in writing. If at any time Silver Valley Unified School District is unable to complete their responsibilities under this agreement, they shall immediately provide written notice to Apple Valley Unified School District.

**Whereas**, if the consortium is awarded funding through the 2024-25 CTE Incentive Grant (Round 10), the distribution of funds will be based proportionally on the following 2023-24 Reported Grades 7-12 P2 ADA as listed below as indicated in the CTEIG Program Grant Management System (PGMS):

**Whereas**, the CTE Incentive Grant requires that the Lead Agency assume the responsibility of the participating members of the consortium to comply with the requirements of the grant, as articulated in the CTEIG 2024-25 Request for Applications (RFA - <https://www.cde.ca.gov/fg/fo/r17/documents/2024-25cteigrfa.docx>), including, but not limited to, the match funding requirement for the duration of the grant term and all CDE General Assurances and Certifications (<https://www.cde.ca.gov/fg/fo/fm/generalassurances2024-25.asp>); and

**Whereas**, the purpose of the consortium is to work collaboratively as a region; and

**Whereas**, no participating district shall be harmed if another member district defaults or does not comply with the requirements for the CTE Incentive Grant,

**Therefore** be it resolved that Silver Valley Unified School District agrees to meet all programmatic, reporting, and funding requirements set forth by the CTE Incentive Grant, and should Silver Valley Unified School District cause an adverse action due to non-compliance of these requirements, Silver Valley Unified School District shall hold the other districts in the consortium harmless, and shall reimburse all charges levied against Apple Valley Unified School District and the consortium by the CDE in regards to the CTE Incentive Grant due to the Silver Valley Unified School District's actions.

**Therefore** be it resolved that Silver Valley Unified School District agrees to provide regular financial activity reports and implementation updates to consortium members for the purposes of ensuring consortium funds are being utilized in a timely manner, in accordance with the application narratives and documents.

**Therefore** be it resolved that Apple Valley Unified School District shall distribute initial allocation of Round 10 CTE Incentive Grant funds equally between LEAs for up to \$25,000 for each LEA and then proportionally according to the ADA distribution in the chart labeled Table 1 for any additional dollars. Upon adjustments to the Grant amount made by CDE, the allocation of funds shall be adjusted pro rata according to Table 1.

**Therefore** be it resolved that Silver Valley Unified School District agrees that the Superintendent council of the consortium (Mountain Desert Career Pathways Governing Board) has the authority to redistribute consortium funds in two circumstances: (1) by district request for their own allocation or (2) the Superintendent council determines a district will not be able to utilize all of their assigned funds within the grant implementation window. Silver Valley Unified School District agrees that any funds redistributed in this manner within the last six months of the implementation window may be distributed either according to Table 1 or another method as agreed upon by a quorum of the Superintendent council of the consortium (Mountain Desert Career Pathways Governing Board) in the interest of ensuring all funds are expended by the end of the round implementation window (December 31, 2026).
