**Resolution Authorizing Public Bidding for Yermo School New Gymnasium  
Project Bid No. 20240270-01**

**WHEREAS**, the Silver Valley Unified School District ("District") has determined that it is in the best interest of the District and the students to construct a new gymnasium at Yermo School; and

**WHEREAS**, the District has identified the need for a qualified contractor to complete the construction of the gymnasium, requiring the District to go out to public bid to secure a contractor for this project; and

**WHEREAS**, the District intends to proceed with Bid No. 20240270-01 for the Yermo School New Gymnasium Project in accordance with applicable state and federal laws, including the California Public Contract Code, which governs public works projects; and

**WHEREAS**, the estimated cost of the Yermo School New Gymnasium Project exceeds the limits specified in Public Contract Code Section 20111, thereby necessitating a formal bidding process; and

**WHEREAS**, the District desires to ensure fair and open competition, in compliance with the District's procurement policies and applicable public bidding requirements;

**NOW, THEREFORE, BE IT RESOLVED** that the Board of Trustees of the Silver Valley Unified School District hereby authorizes the administration to:

1. Proceed with the preparation of Bid No. 20240270-01, including all necessary plans, specifications, and bid documents for the Yermo School New Gymnasium Project.
2. Advertise the project for public bidding in accordance with applicable law, ensuring adequate notice and opportunity for qualified contractors to submit bids.
3. Take any and all actions necessary to solicit and receive bids for the Yermo School New Gymnasium Project in compliance with state and federal laws, including the issuance of any required notices, publications, job walks and postings.
4. Review and evaluate the submitted bids and return to the Board with a recommendation for the award of the contract to the lowest responsive and responsible bidder.
