Any stand by time incurred by PPI employees because of work stoppage, intermittent access of materials or by workers to area, and unscheduled delays will be considered beyond scope items, reimbursed in accordance with terms in item two. (2)

4. Primed Productions Inc. will be excluded from the responsibility to meet scheduling or performance parameters prescribed hitherto or during the enactment of this agreement because of force majeure or any other delays beyond the control of Primed Productions Inc .

** Primed Productions Inc. is to be named as additional insured prior to any work being performed.

*** **Payment Terms:** 50% Deposit due 30 days prior to installation. Balance due upon completion of installation. Checks to be written to Primed Productions Inc.

The price shown may not include permits, license, bonding fees, federal, state, or local taxes, local labor, Union Wages if Required, flights, hotels, forklift/cranes, and security of equipment, all of which shall be the responsibility of the lessee.
